8. Children of families who are committed members of other Christian denominations that are part of CTBI, Churches Together in Britain and Ireland or the Evangelical Alliance. Evidence of Baptism (or dedication) and practice provided by a priest or minister of a designated place of worship will be required. **3**

9. Children who are members of other faiths. Evidence of membership of the faith of religious commitment provided by a priest, minister or religious leader of a designated place of worship will be required. **2**

10. Any other children. **6**
