

1. Background

As part of our Lambeth 2030 Borough Plan, Lambeth is developing a local approach to becoming an Age Friendly borough. An Age Friendly borough is a place that enables people to age well and live a good later life. To help us with this ambition, we are building on the World Health Organisation's Age Friendly Cities and Communities Framework. This Framework will help us to foster social and built environments that promote healthy and active later lives for all residents.

To develop our local approach, Lambeth has focused on key areas of community life which we know are important in supporting people to age well. These are: transport, outdoor spaces and buildings, housing, social participation and inclusion, civic participation and employment, community support and health services, and communication and information. These key areas will form the 'domains' of our action plan – the actions we take to become age-friendly will be grouped by each of the eight domains. Throughout the Plan, equity and justice will be central to our approach.

We are all ageing but we know that residents will have their own perception about when, if at all, they feel 'older'. However, to help encourage healthier ageing earlier, Age Friendly Lambeth focuses on adults aged 50 years and above.

We understand that every individual's experience of ageing will differ and that how we experience and interact with our local environment and community changes as we age. Each resident in Lambeth will have their own perspectives of what ageing means to them. Unfortunately, we also know that ageing and older age is often negatively stereotyped. Age Friendly Lambeth looks to challenge these negative stereotypes and instead to recognise and celebrate the diverse lived experiences and skills of older residents and the contributions they make to Lambeth life.

2. Aim

Age Friendly Lambeth's aim is to ensure Lambeth is a place that enables its residents to grow old and age well by working together with residents and partners across the borough to identify, co-ordinate and implement age-friendly borough initiatives.

3. How the draft Action Plan was developed

The draft action plan has been developed by:

• Reviewing the findings from Council consultations and Age Friendly Engagements including:

- Focus groups with older residents
- o Age Well Festival insights
- Age Friendly Engagement (2023)
- Age Friendly Forum & outreach
- o Engagement with stakeholders
- Reviewing the evidence base around ageing
- Learning from the Centre for Ageing Better, and from what's working well in other Age Friendly communities.
- Speaking with Council colleagues to understand current work taking place to support older adults and how they can support future Age Friendly work.

4. The draft Age Friendly Lambeth Action Plan

Fostering an Age Friendly Borough is everyone's responsibility and while this draft Action Plan cannot address all challenges the Plan does represent a positive and important step along Lambeth's journey of becoming an Age Friendly Borough.

Please note that the following is a **draft** Action Plan and captures the actions that have been developed so far. Further work to refine the Plan is ongoing and the findings from the consultation will help inform this development.

We are grateful to the Age Friendly Forum for their recent feedback on the draft Action Plan which has informed our approach to this consultation and will continue to feed into the Action Plan's development.

5. Implementation

The Age Friendly Lambeth team will work with colleagues and partners to support them to implement the finalised actions and to keep up to date with progress, successes and any challenges which may arise.

6. Monitoring

We have designed an approach to monitor the actions in the plan which includes reporting timelines and data to be collected. Progress against each action will be monitored at regular intervals during the implementation and details of monitoring arrangements will be included in the final Action Plan.

7. Governance

We're currently developing a governance framework for Age Friendly Lambeth to ensure that the Council, partners and the public are kept up to date with progress and have opportunity to input during the implementation of the Action Plan. We'll publish this process with the finalised Action Plan in autumn 2024.
