

Proposed parking controls Streatham Area

Dear Occupier,

Local residents have told us repeatedly about parking problems in their area. Generally, residents feel the problem is being caused by commuters who park and complete their journey by public transport or those working in nearby businesses.

In 2016, the council commissioned independent parking surveys to assess pressure in the non-Controlled Parking Zone areas to the south of the borough. The parking survey data suggests that much of the Streatham area is experiencing acute parking problems. The full parking survey reports are available at www.lambeth.gov.uk/streathamcpz.

A key part of the survey works was to recommend the order in which all areas could be consulted. However, following discussion with Ward Councillors a decision was taken to survey all residents to find out which of these areas are in favour of parking controls. This will help us decide which locations are under the most parking pressure and would like us to consider the area for a consultation on parking controls.

We know that CPZs can be a contentious issue, the main reason being that residents are generally required to purchase a permit in order to park in a CPZ. The current costs of parking permits is enclosed.

We are aware that many of the roads south of the borough are affected by parking congestion, but many residents may choose to continue with their current parking situation rather than pay for a permit. Therefore, we would like to see how much support there is for controls in the area before allocating the funding and resource to undertake the full CPZ consultation process. Please let us know your views.

How can I give my views?

You can complete and submit your online survey using the following link, www.lambeth.gov.uk/streathamcpz by the closing date of **12 March 2018**. You will need your Unique Reference Number (URN) enclosed to authenticate your submission.

The decision on how to proceed will be based on to the responses received during this survey. Therefore your participation is very important.

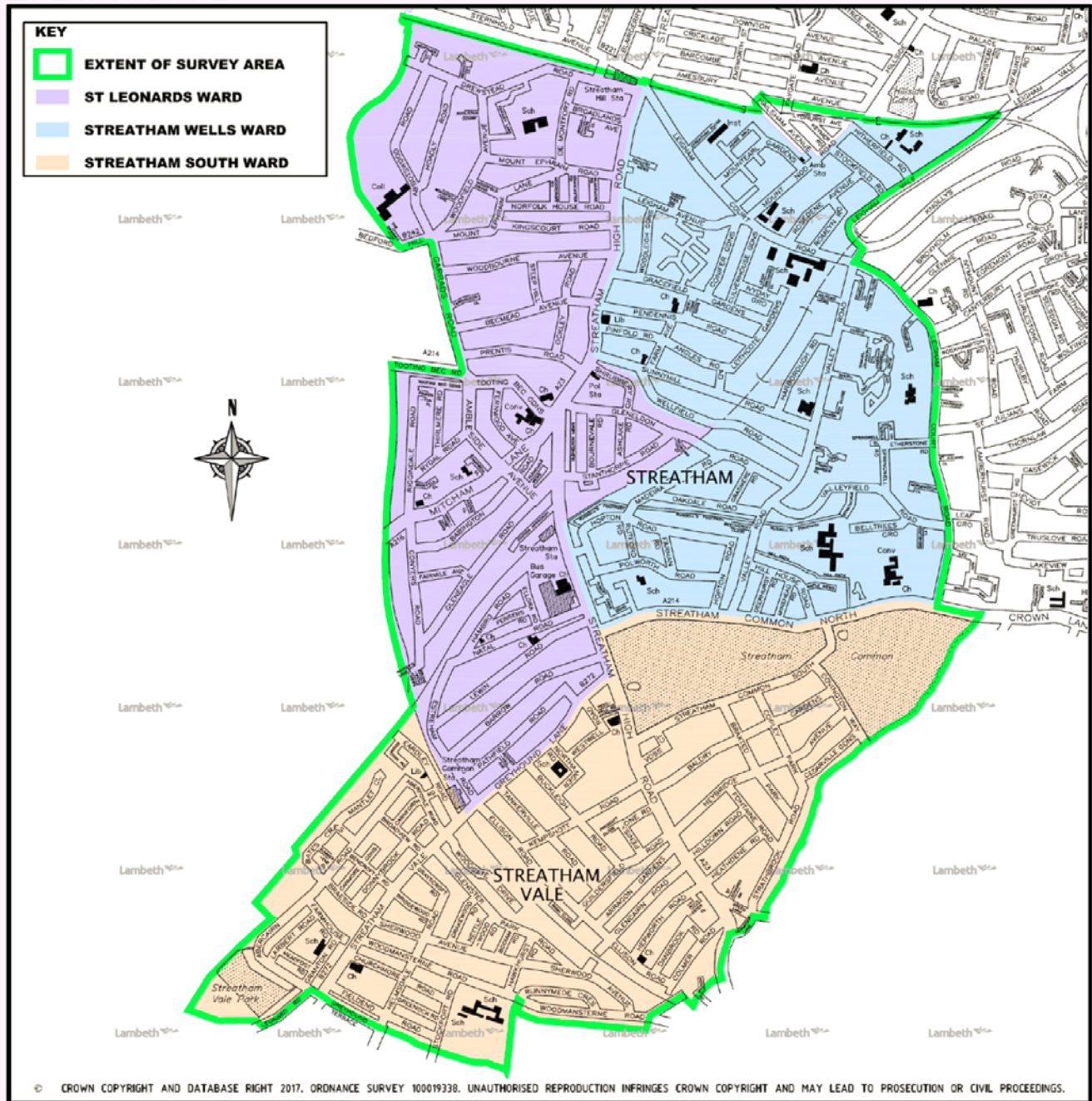

A report analysing the results of the survey and officers' recommendations will be presented in a report to the Cabinet Member for Housing and Environment. Once a decision is made we will let you know the outcome.

Emissions (CO₂ g/km)/Engine size (CC) charging rules

CO₂ (g/km) can be found at section V7 under vehicle details on your V5/C (vehicle registration document).

Cylinder Capacity (CC) (engine size) can be found at section P1 on your V5/C

Petrol/diesel (heavy oil) and bio-diesel - If your vehicle was registered before 1st of March 2001 then the band that your vehicle falls into will be determined by engine size i.e. the CC

Petrol/diesel (heavy oil) and bio-diesel – If your vehicle was registered after 1st of March 2001 then the band that your vehicle falls into will be determined by emissions i.e. CO₂

Alternative fuels including hybrids – If your vehicle was registered before 1st of March 2001 then the bands that your vehicle falls into will be determined by engine size. Due to the fact that it is considered to be cleaner than its petrol/diesel equivalents it will fall discounted to one band lower e.g. a vehicle with a CC greater than 3000 would fall into band 5 rather than band 6. Alternative fuels including hybrids – If your vehicle was registered after 1st of March 2001 then the band that your vehicle falls into will be determined by emissions i.e. CO₂. If your V5/C does not list any emissions please call 020 7926 9000 to determine the price band.

Electric cars (not hybrids) – If your vehicle was registered before 1st of March 2001 then the bands that your vehicle falls into will be determined by engine size. Due to the fact that it is considered to be cleaner than its petrol/diesel equivalents it will fall discounted to one band lower e.g. a vehicle with a CC greater than 3000 would fall into band 5 rather than band 6. If your V5/C does not list a CC please call 020 7926 9000 to determine the price band.

Electric cars (not hybrids) – If your vehicle was registered after 1st of March 2001 then the band that your vehicle falls into will be determined by emissions i.e. CO₂. If your V5/C does not list any emissions please call 020 7926 9000 to determine the price band.

Foreign registered vehicles – These will always be priced in band 4. Please also note that foreign registered vehicles will only be issued with a maximum of 6 months worth of permits, after this no other permits will be issued until the car is registered and taxed in the UK.

Other vehicles – we are aware that there are some exceptions to the above e.g. LGVs, Euro 4 LGVs and certain alternate fuels and if your vehicle does not fall neatly into the above categories then please either contact us on 020 7926 9000 or call into the Lambeth Contact Centre or one of our parking shops which are listed in the FAQ section of the application form. Please note - if your engine has been converted since manufacture this conversion must be updated and reflected on your V5/C (vehicle registration document).
